## ORDINANCE NO. <u>343</u>

AN ORDINANCE AMENDING THE COMPREHENSIVE PLAN OF THE TOWN OF HAVANA TO AMEND THE FIVE-YEAR SCHEDULE OF CAPITAL IMPROVEMENTS CONTAINED IN THE CAPITAL IMPROVEMENTS ELEMENT TO SUPPORT THE FUTURE LAND USE MAP AMENDMENT FOR THE HINSON PRESERVE; PROVIDING FOR THE LEGAL STATUS OF SAID COMPREHENSIVE PLAN AS AMENDED; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF HAVANA, FLORIDA:

SECTION 1. That the Comprehensive Plan of the Town of Havana shall be amended by adding a revised Five-year Schedule of Capital Improvements to the Capital Improvements Element attached hereto as **Exhibit A** and made a part hereof..

SECTION 2. Applicability and Effect.

The applicability and effect of these amendments to the Town of Havana Plan shall be as provided by the Local Government Comprehensive Planning and Land Development Regulation Act, Sections 163.3161 through 163.3215, Florida Statutes.

SECTION 3. Conflict with Other Ordinances and Codes.

All ordinances or parts of ordinances of the Code of Laws of the Town of Havana, Florida, in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

SECTION 4. Severability.

If any provision or portion of this Ordinance is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portions of this Ordinance shall remain in full force and effect.

SECTION 5. Effective Date.

The effective date of these plan amendments shall be according to law and the applicable statues and regulations pertaining thereto.
